Consider an ordinance ordering a General Election to be held on Saturday, May 2, 2020, for the purpose of electing a Mayor, at-large, and two (2) Council Members, at-large, for a two (2) year term; providing for the publication and posting of notice; and providing for early voting dates, times and locations.
