ACTION ITEMS

4. DISCUSS AND CONSIDER RESOLUTION NO. 16-0707 AUTHORIZING THE MAYOR TO SIGN A JOINT OPERATIONS AGREEMENT WITH THE FRIENDS OF THE E.M. GILLIAM MEMORIAL LIBRARY FOR THE CONSTRUCTION OF AN ADDITION TO THE LIBRARY BUILDING.

Mayor Burgess invited "Friends of the Library" Representative Marlena Dyess who addressed the Council and referenced Resolution 2013-0202B Supporting the Library Expansion. In 2015 the Council included \$30,000 in the Series 2015 Tax Note for the Library Expansion.

Mayor Burgess expressed concern on the bid process and legal requirements. Marlena Dyess stated 3 bids had been received, the one selected was provided for the Council's consideration with the aforementioned agenda item.

The Council Members held a discussion, they expressed concern on the age and condition of the current building and discussed reserving funds for a grant match.

Mayor Burgess concluded the discussion and requested a motion.

MOTION Council Member Eggen motioned to approve Resolution No. 16-0707 Authorizing the Mayor to Sign a Joint Operations Agreement with the Friends of the E.M. Gilliam Memorial Library for the Construction of an Addition to the Library Building; with the Stipulation of Legal Review by the City Attorney on the legal requirements.

SECOND Council Member Madrigal

VOTE Motion passed 4-0; Resolution No 16-0707 with a stipulation of legal review.

City Administrator Wheat requested if the Council wanted this item to return for reconsideration. The Council unanimously agreed that the final determination was dependent on the City Attorney's findings.
