6. Discuss and Consider Resolution R16-0804C Authorizing the submittal of a USDA Loan for the Development of Infrastructure in Southeast Wilmer in the Amount of \$1.7 million.

Mayor Burgess invited Rockhall Funding Loan Originator Frankie Martinez, who advised the Council regarding the aforementioned item. City Administrator Wheat cautioned the Council on the details of the loan agreement and suggested approval of the Resolution to consider discussion and clarification on the loan requirements.

Discuss and consider by minute entry approval of a final/ conveyance plat for Sunridge Business Park, Block G, Lots 1-4, an 85.7± acre property that is generally located on the south side of Fulghum Road, approximately 500± feet east of Interstate Highway 45, in Wilmer, Texas. Applicant: Wilmer Fulghum 161, LP

Mayor Burgess invited City Planner Sefko, who provided the Council a brief update on the Development Application submitted for a Final Plat Conveyance on the aforementioned property. Mayor thanked City Planner Sefko and requested a motion.

MOTION: Council Member Madrigal motioned to approve the final/ conveyance plat for Sunridge Business Park, Block G, Lots 1-4 subject to the following:

- a) Finalization of the wording of all language blocks by the City's Engineer and by the City's Attorney prior to recordation of the plat at the Country; and
- b) Replatting each developable lot, as each prepares or actual development, to establish the purpose, location and configuration of required easements, as may be deemed necessary by the City.
