CALL TO ORDER At 7:02 pm, Mayor Wealthy-Williams called the meeting to order. Members present were Mayor Wealthy-Williams, Mayor Pro Tem Petta, Councilmember Campos, Councilmember Eggen, Councilmember Madrigal and Councilmember Ramirez.

CITIZENS' COMMENTS – Diane Alrousan addressed the Council concerning the Clean-Up Week. Ann Hester addressed the Council concerning the Appraisal District's ratings of the houses in Wilmer this year and encouraged everyone to protest their rate and help those who do not know how.

Mary Phinney addressed the Council concerning the noise pollution and air pollution being caused by Redneck Diesel. She stated that they keep the trucks running at all hours of the night and affect those who live near their location.

Victor Pena addressed the Council concerning putting more money and effort into creating a downtown along Belt Line so that Wilmer can attract more businesses and restaurants. It can also be a destination to be proud of.
